### **Privacy Policy**

Courtney Snyder, MD, PLLC ("us", "we", or "our") operates the Http://www.courtneysnydermd.com website (hereinafter referred to as the "Service").

#### **Definitions**

#### Service

Service is the Http://www.courtneysnydermd.com website operated by Courtney Snyder, MD, PLLC

#### Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

#### Usage Data

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

#### Cookies

Cookies are small files stored on your device (computer or mobile

device).

#### Data Controller

#### **Personal Data**

# Data under the General Data Protection Regulation (GDPR)
